Chairman Duffey called the meeting to order at 1:31 p.m.

Deputy Director Fouche called the role. Representatives Duffey, Gavarone, Manning, Boggs, Ramos and Senators Uecker, Balderson, Kunze, Skindell, and Thomas were in attendance. Deputy Director Fouche stated a quorum was present. Chairman Duffey asked the Committee members to review the September 18, 2017 minutes. The minutes were approved as presented.

Director Wolpert read the No Change Agenda. Chairman Duffey called for questions or comments on the No Change Agenda. There were no questions from the Committee or public. Director Wolpert read the Regular Agenda. Items 8 was placed into To Be Refined status at 1:10 p.m. Item 20 was moved to the review portion of the agenda. Chairman Duffey called for questions or comments on the Regular Agenda. There were no questions from the Committee or public. Chairman Duffey temporarily recessed the Committee at 1:34 p.m.

Chairman Duffey called the meeting back to order at 1:35 p.m. to address the review portion of the agenda. Chairman Duffey called Jim Bownas, Northeast Ohio Academy of Chiropractic, to provide opponent testimony regarding item 20. Mr. Bownas believes ODJFS did not take the chiropractic adverse impact on business into account with proposed rule 5101:2-12-08. Mr. Bownas recommended the Committee refer the rule back to CSI for further consideration. Chairman Duffey stated proposed rule 5101:2-12-08 was not for five year review and that only the amendment within the rule was before the Committee. Chairman Duffey asked if he was correct in saying Mr. Bownas' concerns were within a section of the rule not being amended. Mr. Bownas stated that was correct. Chairman Duffey stated Mr. Bownas could bring his concerns to the agency for an amendment to the rule or the General Assembly for a statutory change.

Chairman Duffey announced that on November 16, 2017 he would be bringing back the "Bucket of Invalidation."

Chairman Duffey reminded the public of the next JCARR meeting on Monday, October 23, 2017 at 1:30 p.m. in the William McKinley Hearing Room.

Chairman Duffey adjourned the meeting at 1:38 p.m.
