Director Wolpert read the No Change Agenda. Chairman Callender called for questions or comments on the No Change Agenda. There were no questions from the Committee or public. Director Wolpert read the Regular Agenda. Items ten and twenty-six were moved to the review portion of the agenda. Chairman Callender called for questions or comments on the Regular Agenda. There were no questions from the Committee or public.

Chairman Callender directed the Committee to written opposition testimony for Regular Agenda item ten on their iPads. Chairman Callender called Terri Marlow, member of the Ohio Foreign Language Association, for opponent testimony on Regular Agenda item ten. There were no questions for the witness.

Representative Hillyer moved to recommend invalidation of proposed rule 3301-35-04 (Regular Agenda item ten) based on Legislative intent, conflicts with another rule, incomplete Rule Summary and Fiscal Analysis, and adverse business impact justification. Senator Craig seconded the motion. The motion passed with nine votes. There were no further actions by the Committee.

Chairman Callender called Dean Koch, White's Landing Fisheries Inc., to provide opponent testimony on Regular Agenda item twenty-six. There were no questions or actions from the Committee on Regular Agenda item twenty-six.

Chairman Callender reminded the public of the next JCARR meeting on Monday, November 8, 2021 at 1:30 p.m. in the William McKinley Hearing Room.

Chairman Callender adjourned the meeting at 11:29 a.m.
