Chairwoman Gavarone called the meeting to order at 1:30 p.m.

Deputy Director Fouche called the roll. Representatives Hillyer, Boggs, Skindell, and Senators Gavarone, Lang, Brenner and Craig, were in attendance. Representative Fraizer was substituting for Representative Stewart. Representative Callender was excused from the meeting. The Chairwoman asked the Committee members to review the September 27th minutes. The minutes were approved as presented.

Director Wolpert read the No Change Agenda. The Chairwoman called for questions or comments on the No Change Agenda. There were no questions or comments from the Committee or public. Director Wolpert read the Regular Agenda. Rule 3701-47-07 of item twelve on the Regular Agenda was moved to the review portion of the agenda. The Chair called for questions or comments on the items other than rule 3701-47-07 on the Regular Agenda. There were no questions or comments from the Committee or public. Chairwoman Gavarone temporarily recessed the Committee at 1:33 p.m.

Chairwoman Gavarone called the meeting back to order at 1:34 p.m. to discuss the review portion of the agenda. Chairwoman called Lance Himes and Tyler Herrmann from the Ohio Department of Health to answer member questions on 3701-47-07. Representatives Skindell and Boggs had questions and comments for Mr. Himes and Mr. Herrmann regarding definitions within the rule, CSI consideration and opportunities for stakeholder feedback.

Representative Skindell moved to recommend invalidation of rule 3701-47-07 located under Regular Agenda item twelve based on prong violations relating to legislative intent, conflicting with rules of other agencies and misrepresentation within the Rule Summary and Fiscal Analysis. Representative Boggs seconded the motion. The motion did not pass. There were no further actions from the Committee on rule 3701-47-07.


The Chairwoman reminded the committee that the next JCARR meeting is on Monday, November 14th at 1:30pm.

The Chairwoman adjourned the meeting at 1:52 p.m.
